Sub:-Cancellation of Inter Circle transfer of SDEs on direction of CVO - Case
SDEs appearing in ODI list.

Respected Sir,

I want to bring to your kind notice that certain SDEs, who have faced some disciplinary action in the past and have either been exonerated or their punishment is not in vague i.e. the currency of punishment is over, have been transferred out of circle vide BSNL Corporate Office letter no.21-01/2010-Pers.II dated 23/4/2010 wherein 17 SDEs of Rajasthan Circle have been transferred.

The matter was taken up with the Central Head Quarters through Association for cancellation of transfer in respect of nine such SDEs who have either been exonerated or their currency of punishment is over. It has been given to understand that the transfer will be considered for cancellation only in respect of cases whose names are deleted from ODI list.

It is, therefore, requested to kindly get all the cases reviewed at Circle level and to take up the cases with local Authorities of CBI for deletion of such names whose punishment is over or who have been exonerated completely. Your recommendations in each case on the basis of present performance & conduct of the executive may be important in the cases and the persons wrongly placed in ODI list can be removed by CBI. The CBI may kindly be requested by your good office to revise the ODI list after deleting of such names. So that we may take up the cases with Central Headquarter for cancellation of the transfer of such SDEs. The list of such SDEs along with the present status of CBI/Disciplinary case in respect of each SDE is enclosed for ready reference.

I hope your kind office will take necessary action immediately to remove the hardship of the executives suffering from Inter Circle transfer.
