Sub: - Regarding pending issues related to transfer & posting of Executive's

Respected Sir,

We are constraint & want to draw your kind attention towards the following pending transfer & pending issues causing unrest in the mind of our members. I seek your kind intervention in resolving the following issues.

(1). **Shri Jagdish Prasad Sad, SDE** transferred & posted from **Nagaur to Sri Gangbanger**. The officer has requested your good office for change of posting station at **Ajmer, Pali or Jodhpur** due to his following family circumstances:

(a) Officer has already served **hard tenure station at Arunachal Pradesh** under ETR, Kolkata while working as JTO for more than three years.

(b) He is to look after his 76 years old ailing father suffering from **Ghatiya** on both legs who is unable to even move and required regular attended.

(c) His mother is the patient of high BP and severe diabetics and Asthma for last several years and needs regular medical checkup.

(d) The Sri Ganganagar SSA is about 425KM away from his native place & it is very difficult to look after parents & family (request for change is already submitted).

(2). **Shri Sudeep Vyas, JTO** transferred & posted from **Pali to Sirohi**. The officer has requested your good office for cancellation or retention for one year at Pali Marwar due to his following family circumstances:

(a) Officer has already served **tenure station at Mount Abu before formation of Sirohi SSA**.

(b) Spouse of Shri Sudeep Vyas, is serving in State Government (Education) at sojat city area in Pali. As per the executives transfer policy para 6(g), request for posting of husband and wife at the same station shall be considered, if the employee's spouse is serving in Central/State Government or a Public Sector Undertaking (PSU).

(3) **Shri Kurda Ram, SDE, PGM TD**, Jaipur transferred on promotion from **Jaipur to Jaisalmer**. The officer has requested your good office for cancellation of transfer order due to his following family circumstances:

(a) Officer himself has medical problem being a heart patient as adequate medical facilities are not available at Jaisalmer.

(b) Spouse of Shri Kurda Ram, is serving in Central Government (Kendriya Vidyalaya) at Jaipur. The Central Government spouse case for posting of husband and wife at the same station be consider as per **Department of Personal and Training office memorandum F. No. 28034/9/2009-Estt.(A) dated 30th September 2009(copy enclosed)**. The BSNL executives transfer policy para 6(g) also have provision, request for posting of husband and wife at the same station shall be considered, if the employee's spouse is serving in Central/State Government or a Public Sector Undertaking (PSU).

(4)**Shri A.L.Koli, JTO**, transferred from Bhilwara to Udaipur on stay basis. The officer has requested your good office for cancellation of transfer order due wrong stay calculation & his following family circumstances:

(a) **Shri A.L.Koli was appointed at Nembahera SDCA in Chittorgarth SSA on dated 20/11/1983 & then he has been transfer & posted in Bhilwara SSA on dated 13/07/1993.**The stay counted since appointment in Bhilwara is wrong & transfer on stay basis be revived as per corrected date of joining in Bhilwara i.e 13/07/1993.

(b) His 23 years daughter is deaf & dumb and she needs proper care & regular medical checkup. The representation of wrong stay along with disabled certificate is enclosed herewith (copy enclosed).

(5)**Shri O.P.Sharma, SDE (Civil), Hanuman Garth** transfer request was registered for Jaipur. His request was not consider in the plea that Hanuman Garth station was not cover in the hard tenure SSA's declared vide CGMT letter no. STA/1-113/R/II/46 dated 17/10/2001.

(a) His representation already forwarded for consideration to GM (HR) vide No.:AIBSNLEA/RAJ./2009-10 / 40 on dated 14th May 2010 & pending since two & half month(Copy enclosed).

(6) Shri B.R.Karamchandani, SDE (MSC), Jodhpur transferred & posted from **Jodhpur to Udaipur**. The officer has requested your good office for cancellation or change of posting station at **Pali or Barmer** due to his following family circumstances:

(a) **Shri B.R.Karamchandani, SDE** holding the charge of **organizing Secretary(west) of AIBSNLEA,Rajasthan Circle**. In view of concession of immunity from transfer for office bearer & goodwill of Association, you are therefore requested to kindly cancel or change of posting in west area (Pali or Barmer) to organize the day to day activity of Association in west area.

(b) His mother is 85 years old & her state of health is critical. She needs continuous observation and may require hospitalization at any time.

(7) **Shri Dayal Das, JTO (Civil)**, transferred & posted from Jaipur to Nagour. The officer has requested your good office for cancellation **due to pick & choose transfer** or change of posting station at **Ajmer, Alwar or Swai Madhopur** due to his following family circumstances:

(a) Officer has already served **tenure station at Suratgarth in Sriganganagar SSA** while working as JTO for more than four years.

(b) He is resident of Jaipur district and Nagour is about 250KM away from his native place & it is very difficult to look after parents & family requirement.

(c) His father is the patient of **"Epilepsy"** for last several years and needs regular medical checkup. He is frequently needed of medical aid and also there is no person to look after in his ailing days.

(8)**Shri Abdul Raouf, SDE** presently working as AGM (IT&MIS) at Chittorgarth & requested to transfer from Chittorgarth to Kota. His request for Kota is pending since October 2009 & not consider due to following reasons.

(a) Shri Abdul Raouf, SDE was obeyed the order of local officiating promotion from SDE to DE & joined in Chittorgarth SSA on dated 19/10/2009.

(b) Hon'ble CGMT assured to Association that his request for Kota will consider in the next officiating order or regular incumbent of STS in Chittorgarth SSA.

(c) Officer is requested to consider the transfer on own cost due to his family requirements/problems (representation enclosed).

(9)**Shri L.N.Sharma, SDE**, transferred & posted from Bikaner to Nagour . The officer has requested your good office for cancellation or retention for one year at Bikaner due to his following family circumstances:

(3)

(a) The Bikaner SSA is difficult SSA & already declared as hard tenure by BSNL corporate office. The willingness for hard station is very less, so the executives working in tenure SSA/station may continue to work in these SSA's.

(b) Officer has already served **hard tenure station in Sri Ganganagar SSA**, while working as SDE for about three years.

(c) As per his performance the case for retention at Bikaner was recommended by GMTD, Bikaner.

(10) **Shri Komal Prasad, JTO**, presently working as JTO at Nawalgarh & his transfer request registered from Jhunjhunu to Jaipur. His request for Jaipur is pending since May 2008. The officer has requested your good office for consideration of request due to his following family circumstances:

(a) Shri Komal Prasad himself is heart patient & recently undergone angiography treatment & also needs close observation of his doctor at Jaipur.

(b) His wife is physically handicapped & due her 40% disabled the family circumstances of Shri Komal Prasad is very critical.


(c) He has already completed the tenure period i.e. two years at Jhunjhunu.

(11) **Shri B.R.Poonia, SDE**, request was considered and transferred to Jaipur but not relieved till date. Now he is UN willing & wants to cancel the request transfer due to his daughter education at Sri Ganganagar. The representation of the officer is recommended by GMTD, Sri Ganganagar.

In view of the above circumstances of the officers, I request you to kindly consider their requests on sympathetic ground for revising their posting order. We shall be thankful in anticipation.
