No separate order will be issued in this regard.**

4. The service in higher Grade under this arrangement will not count for any benefit in matters of future promotion, seniority. This looking after arrangement will not confer any extra remuneration / fixation benefits.


5. The executives ordered to look after the duties of AGM/DE through this order will exercise the functional powers (Administrative and Financial) attached with the post.
