**ORDER**

**Sub : Posting on promotion of Executives SDE(T) to the Executive Grade (STS) in Telecom. Operation Stream in the IDA Scale of Rs. 29100-54500/- (pre-revised Rs. 14500-350-18700), local officiating basis - regarding**

Chief General Manager, BSNL, Rajasthan Telecom Circle, Jaipur is pleased to promote 79 Executives SDE(T), as per list enclosed as Annexure, locally, purely on temporary basis to officiate in the grade of Executive Grade (STS) in Telecom. Operation Stream in the IDA pay scale of Rs.29100-54500/- (pre-revised Rs.14500-350-18700) for a period of not more than 180 days. **They will automatically stand reverted on Afternoon of 19<sup>th</sup> June, 2012 or on joining of regular incumbent or by any other orders issued by this office or till retirement, whichever is earlier. No separate order will be issued for reversion.** Their pay on local officiating promotion is to be fixed under the provision of letter No. 1-50/2008-PAT(BSNL) dated 05.03.2009. If any Executives SDE(T), has already got IDA up gradation in the pay scale of Rs. 29100-54500/- (pre-revised Rs.14500-350-18700), his pay on local officiating will be governed as per BSNL executives Time bound promotional policy guidelines issued by BSNL HQ ND No. 400-61/2004-Pers.I/308 dated 18.01.2007 and this office letter dated 31.01.2007.

This local officiating promotion does not confer any claim to them for seniority in Executive Grade (STS) in Telecom. Operation Stream for regularization of the same or for benefit such as seniority etc. in a future date. The competent authority reserves the right to terminate the local officiating promotion without assigning any reason or giving notice etc. to the concerned Executives SDE(T).

In case of any disciplinary/Vigilance case of the type referred in BSNL CO letter No. CVO/BSNL/001/06 dated 12.09.2006 is pending against the executive(s) or any punishment of stoppage of increment is in operation; or the executive(s) is/are on deputation to TCIL etc. the executive(s) should not be promoted without obtaining the specific approval of this office. Information in this regard may be brought to the notice of this office as early as possible.

On promotion these Executives SDE(T) are posted in the SSA shown against each in Annexure. The Executives SDE(T) who are posted in SSA other than their present SSA/Unit are transferred as Executives SDE(T) and after joining in new SSA/Unit they are promoted to officiate in Executive(STS) in Telecom. Operation Stream. The SSA/Unit heads must ensure the relieving of Executives SDE(T) for joining their new assignment on officiating promotion **not later than 06.01.2012** positively and report compliance by FAX. Non-relieving of any Executives SDE(T) will be personal responsibility of SSA/Unit head.

The SSA/Unit Head will ensure that the Executives SDE(T) posted to officiate as AGM/ DE in their SSAs are to be transferred to the stations as Executives SDE(T) where

they are proposed to be posted and then promoted as AGM/ DE at that station in case they are to be posted to the places other than their present Headquarters.

In case any Executives SDE(T) is not willing to accept the officiating promotion, a clear-cut refusal letter may be taken from Executives SDE(T) on or before 06.01.2012 and a consolidated list of such Executives SDE(T) along with their refusal letters must be submitted to this office by 13.01.2012 positively. These Executives SDE(T) will be debarred for officiating promotion for one year from the date of issue of this order in accordance with the BSNL HQ letter No.19-27/2002-L&A(Pt.)Pers.II dated 01.07.2004.

The leave, if any, requested by the Executives SDE(T) , who has been posted on promotion to different SSA/Unit, should not be granted. He can apply for leave to new Head of SSA/Unit under whom he has been posted only after joining the new post and the new SSA/Unit Head will sanction leave, if it is considered justified in normal course.

Necessary charge report may be furnished to all concerned.
