In continuation of above letters from this Association, in respect of Immunity for exemption in transfer to the Distt. Secretaries, we once again request your kind self for cancellation of the existing transfer orders of Shri B.L.Gupta, Distt. Secy. Alwar-TD & Shri H.L.Swarnkar, Distt. Secy. Bhilwara-TD Branches by extending the Immunity for exemption in transfer as per the guidelines available vide Govt. India, Ministry of Communication letter no. SR-7/72-SR dt. 06-06-1978.

Held in abeyance for few months of Transfer orders cannot be treated as the Immunity. In some recent cases Corporate Office has also followed the guidelines and the orders have been cancelled very next day after issuing the Transfer Orders. In Rajasthan Circle the Immunity was also being provided since long but since last one year it was ignored which is against the goodwill & gesture with the Associations.

We therefore, once again request for extending the Immunity for exemption in transfer to Shri B.L.Gupta, Distt. Secy. Alwar-TD & Shri H.L.Swarnkar, Distt. Secy. Bhilwara-TD Branches and cancel their orders of transfer.
