Presently all such applications have been dumped at Circle Office which is totally against the provisions of transfer policy and legitimate right of an executive to opt posting location to fulfil family/social obligations. Examples are 1. Sh.Shakil Ahmed, SDE, Swaimadhpor to BSNL CO for his daughter study at New Delhi, 2. Mrs.Kumud Umrawal, JTO Ajmer to ALTTC Ghaziabad spouse case 3. Sh.M.C.Gupta, SDE JPTD to BSNL CO for personal reason. It is very sad that the cases raised by AIBSNLEA are not given proper weightage while executives belonging to other association are given out of turn benefit. The developments are causing serious frustration among the executives.

It is therefore, requested to you for your kind consideration of the case at an earliest in a time bound manner. I am sure that the action will be taken accordingly. Regarding forwarding of the transfer application clear guidelines are available from BSNL CO New Delhi that those who stand senior most five in the longest seniority list of the Circle their transfer cases need not to be forwarded but other cases are to be forwarded to BSNL CO for inter Circle transfer purpose.
