Subject: Strict implementation of provisions of Rule 9 of BSNL Transfer Policy – Relieving of officials who have completed deputation period.

To ensure strict implementation of the provisions of transfer under Rule-9 of BSNL Transfer policy in all circles, all circles are directed to check the period of Rule -9 transfer of officers/officials working in their circle including extension and if there is any such case where the officer/official has not been repatriated to his/her parent circle on completion of temporary transfer period including extension, the officer/official may be relieved immediately.

All circles are also requested to ensure the parent unit (circle /SSA/ BA) field entries in ERP in r/o official(s) of Circle /SSA/ BA cadre employees. Further, the parent unit of employees who have transferred under Rule 8 / Mutual may be changed /updated accordingly.
