Sub: Regarding cancellation of transfer of Sh. Jayesh Shukla (AO) from Udaipur to Corporate Office ,New Delhi.

Respected Sir,

It is submitted that Shri Jayesh Shukla (AO),Udaipur has been transferred vide reference letter three from Rajasthan Circle to BSNL, Corporate Office ,New Delhi.

This transfer is against the transfer policy (Ref.-2). According to policy Section-B Para11(d) "For Inter circle transfer, stay will be counted from the date of regular promotion/recruitment into the grade of JTO/JAO and other equivalent to the first level of Executive Hierarchy".

In circle seniority list Sh. Jayesh Shukla number is fifth. Two executives are posting in soft tenure station so they may be relaxed but other two executives are not post in soft tenure station. In general when date of joining of executive is same then training marks decide the seniority in the cadre. In seniority list one executive was scored more marks in training from Sh. Jayesh Shukla. So he is senior from Sh. Jayesh Shukla.(Copy Enclosed)

According to reference letter one Para ii)" An executive already serving in a station/SSA which gets declared as a soft tenure subsequently(during the currency of his posting),shall be entitled for benefit of break in circle tenure. Sh Jayesh Shukla had been served three year at soft tenure station Banswara, Rajasthan w.e.f 14.06.2010 to 20.7.2013.So he is eligible for break in circle tenure.
