Sub: Resumption of up-gradation core module trainings & Online Exams under Executive Promotion Policy (for all streams) w.e.f. 20.02.2023 reg.

Please refer the above letter vide which instructions were issued to postpone core module training & online exams (for all streams) under Executive Promotion Policy for period wef. Oct- 2022 to Feb-2023 due to conduction of JTO(T), JE(T) induction trainings and Karmayogi trainings.

Since the mission Karmayogi first Phase trainings and JTO induction Phase-I trainings are completed, hence it is informed that all up-gradation trainings and exams (for all streams) under Executive Promotion Policy will be resumed w.e.f. 20.02.2023.

Further, it is also informed that for circles (not mapped with ALTTC Ghaziabad/ BRBRAITT Jabalpur) the up-gradation trainings and exams for E1-E2, E2-E3, E3-E4, E4-E5 shall be continued at ZTTCs/RTTCs, but up-gradation trainings for E5-E6 for the circles mapped with these ZTTCs/RTTCs shall be conducted at BRBRAITT, Jabalpur for a period of next two EPP quarters only.

It is also requested to send the data for all cadres (E-1 to E-6) of all executives whom EPP training/exams are pending so that a comprehensive EPP training plan for all streams/cadres may be prepared to ensure that all eligible executives be able to complete their EPP trainings within prescribed 2 year period from the date of issue of respective up-gradation order.
