1. Many SDOs have been fixed responsibilities for excessive disconnection of Land Line connections which is unfair. A single person cannot be held responsible for such downfall until ignorance in duties is established. There should be a collective responsibility in the chain if there is any downfall. In present scenario non availability of telephone instruments, shortage of store and worst performance of CDR System is the main reason for downfall in Land Line Connections which is well known to every body:- The warning letter may please be immediately be withdrawn.
2. Sh. S.C.Gupta D.E.(Bajaj Nagar) diesnon for no reason by Shri R.R.Meena, AM South without calling the explanation and beyond the power of DGM who can only rerecommend for diesnon to Leave sanctioning authorities.:- Diesnon case may please be withdrawn immediately.
3. A warning letters may kindly be circulated among AMs/DGMs for ensuring not to behave rudely with subordinates.
