Sub: Immediately stopping of the process of transfer to the Rural locations on stay basis.

Respected Sir,

This association has discussed in almost all the meetings held with administration that the rural locations are always being filled up by either on the promotions or by those who are coming from other SSAs or by the volunteers. But the process had not been adopted since last few years. Even after several mutual solutions suggested time to time by the associations but all were just rejected. The publication of such list is completely against the transfer policy. If we go through the policy adopted by Circle Office for rotational transfers SSA stay has always taken into account instead of Station tenure. If stay based transfers are done this will not break the SSA/Circle tenure. Hence this may lead the concerned executive to break his tenure out side SSA/Circle.

The SSA is facing about 60% staff shortage and the financial health of SSA is also deteriorating day by day. Instead of searching the solutions for the growth of SSA the Management is wasting the precious time in activities which will definitely lower down the growth of SSA. The procedure adopted since last many years for filling the rural locations had proven smooth & development oriented. This association strongly oppose the path adopted by the management for filling up the rural locations.

Your kind self is hereby again requested for immediately stopping the process of transfer to the rural locations on stay basis.
